<u>Legislative Update</u>

On Friday, October 1, the Alabama Legislature adjourned Sine Die and concluded the First Special Session of 2021. The special session call by Governor Ivey dealt specifically with Prison Infrastructure and Criminal Justice Reform. The bills proposed by the Governor passed in the minimum amount of time, five days. The proposal called for a phase one infrastructure that would build two new prisons. The funding mechanism will be a bond issue of \$785 million and \$400 million from the American Rescue Plan Act that was issued to the state by the federal government. Additionally, more than \$150 million appropriated from the State General Fund budget will be set aside for existing prison updates and maintenance.

The Criminal Justice Reform bills that the Governor included in the special session call allow for those sentenced under the Habitual Felony Offender Act prior to October 1, 2013, to be eligible for resentencing and addressed issues around the release of inmates.

The ALM Advocacy Team worked with lawmakers, staff and other officials to stay advised of the special session beforehand and during the proceedings. We do expect another special session addressing the 2020 census redistricting requirements, later this fall. We will continue to keep track of legislation as it arises and will update you of any legislative issues.

Prison Construction Plan

HB4 – by Rep. Clouse addresses the finance, construction and renovation of prisons. The bill authorizes the Alabama Corrections Institution Finance Authority to issue bonds up to \$785 million to implement a prison modernization plan which would build two new 4,000-bed men's prisons (one in Elmore County and the other in Escambia County) as well as a new women's prison (Elmore County). The plan also provides for the renovation of certain facilities, the creation of the Correctional Facilities Maintenance Fund and the creation the Department of Corrections Correctional Capital Improvement Fund. HB5 – by Rep. Clouse allocated \$400 million from the American Rescue Plan Act - Coronavirus State Fiscal Recovery Revenue Replacement Fund to the Department of Corrections – Correctional Capital Improvement Fund. Click **here** for ACT #2021-547.

HB6 – by Rep. Clouse makes a supplemental appropriation of \$135 million from the unanticipated and unappropriated beginning balance in the State General Fund budget for the fiscal year 2022 to the Department of Corrections - Correctional Capital Improvement Fund. Additionally, the bill makes a supplemental appropriation of \$19 million to the Alabama Bureau of Pardons and Paroles for the purchase and renovation of the Perry County Correctional Facility. Criminal-Justice Reform

HB1 – by Rep. Hill allows for currently incarcerated individuals who committed nonviolent felonies and who were sentenced pursuant to the statutory sentencing range or the Habitual Felony Offender Act prior to October 1, 2013, to be eligible to be resentenced pursuant to the presumptive sentencing standards currently in effect. HB1 was given a favorable report by a House committee but was not given final passage by the full body.

HB2 – by Rep. Hill addresses mandatory supervised release of inmates. The legislation creates new sentencing provisions, requires electronic monitoring for certain released inmates and for the Department of Corrections to provide an inmate with a nondriver ID card prior to release.
