## Police Chiefs' Advisory Committee Enters 13th Year

006 marks the thirteenth year the Police Chiefs' Advisory Committee has served AMIC, MWCF and Alabama's municipalities in bettering law enforcement in the state. At several meetings each year, committee members discuss law enforcement topics and tactics for improving how Alabama's police departments carry out their numerous tasks.

Beginning in 1994, the committee offered training on law enforcement subjects for police chiefs at the League's annual convention. Five years later, in 1999, the committee went to the Alabama Association of Chiefs of Police (AACOP) with the idea of jointly creating an

education committee to administer and oversee a more organized and consistent police chiefs' training program, and in August of 2000, the Certified Law Enforcement Executive Program (CLEEP) was launched.

"It has really grown since then [2000] and allowed us to provide a certification program for Alabama's police chiefs," Roger Owens, education committee member and AMIC/MWCF police safety consultant, said.

Similar to the League's Certified Municipal Official Program, where attendees gain credit hours toward certification for attending seminars, CLEEP training sessions address issues police chiefs face, covering everything from dealing with domestic violence to use of force to pursuit, to name a few.

Last year alone, CLEEP had 564 participants. Any active, full-time police chief in Alabama who is a member of good standing with AACOP is eligible for the program, and all executive-level administrators, with the approval of the chief of their department, may also attend CLEEP (however, administrators will not be certified until they become chiefs themselves and AACOP members of good standing).

success speaks for itself.

"Even the people who were negative toward it in the beginning have changed their minds ... it's the only way to become a professional [law enforcement] organization," Mangham said.

In addition to CLEEP, the education committee also offers a mentoring program where veteran police chiefs volunteer their time and talents to help new chiefs become accustomed to running a department, resulting in better law enforcement in Alabama.

"The program allows us to help those less fortunate cities by sharing with them information, materials and expertise," Owens said.

Between CLEEP and the police chief mentoring program, there's no question as to the education committee's dedication to police department improvement in the state.


"The committee does a lot of good," Owens said. "They are a dedicated group that comes together to better law enforcement and to help all cities be safer and less libelous."

Thomas Mangham, Opelika Police Department chief and education committee chair, says CLEEP training makes police chiefs better managers and teaches them how to deal with problems that may come their way.

"They [police chiefs] are going to train officers to be better officers and to look for ways to lower liability," Mangham said.

From an insurance and workers' compensation standpoint CLEEP is extremely valuable, educating chiefs and, in turn, police officers in tactics for reducing the liability of cities and departments. Mangham says while the need for police chief education wasn't always understood or appreciated for its value, CLEEP's



wonder what could and should have been done to prevent such catastrophic loss of life

and property. The answer is as clear as crystal: preparation, preparation, preparation.

The Alabama League of Municipalities has finished its Municipal Emergency Preparedness Packet (PREP) for assisting municipal officials in preparing for and dealing with emergencies and disasters, both natural and manmade. Hurricane readiness along the state's coastline prompted PREP's creation, but this is just one of the many areas of emergency and disaster management PREP addresses.

Alabama's varying geographic regions, from the rolling foothills of the Appalachians to the roaring surf of the coastal plain, give rise to a number of potential natural disasters. Add to these the possible disasters that people can produce and municipalities need to be ready for anything.

The information included in PREP will serve municipalities regarding emergency and disaster preparation, management and cleanup, and also contains information to assist municipalities in securing state and federal aid before and after an emergency or disaster.

PREP's theme is one of preparation; the more municipalities do to prepare for potential emergencies and disasters the less catch-up they will have to play when an emergency or disaster occurs.

PREP's contents will be updated periodically by the League as the need arises. Though it is distributed in CD-format, municipalities are STRONGLY encouraged to print the material and get the information to your employees as soon as possible. Preparation now prevents problems later.

# Driving a Work Vehicle

Driving a work vehicle is a privilege for employees, not a right. Furthermore, the public entity should have a policy in place that reports the driver history of people responsible for driving vehicles on a regular basis.

There are a two ways to obtain this information: (1) require all employees to provide this information as a condition of employment, or (2) contact the Alabama Department of Public Safety and sign up for online access to driver records.

The Department of Public Safety provides online access to driver records to approved businesses, including municipalities and public corporations.

In order to access this service, the municipality must become an Alabama Interactive Service Subscriber. More information about this service and the forms required for subscription can be found on the state of Alabama's web site, www.alabama.gov, under the "Online Services" section, Business Services. # HOT TOPIC!

ccording to the National Fire Protection Association (NFPA), the primary purpose of exit signs is to give building occupants the information they need to help them find their way out-ofdoors quickly. Placing exit signs in the right locations and providing sufficient lighting around exits could mean the difference between a safe, speedy exit and a slow, confusing one.

The first location where exit signs must be placed, as required by Section 7.10.1.2 of the NFPA's Life Safety Code ®, is at exits, whether they are enclosed stairways, horizontal exits, passageways or outside doors (unless the door is obviously an exit). Section 7.8 of the Life Safety Code requires the area outside an exit door, commonly called an exit discharge, to be illuminated while Section 7.9 says the area must be illuminated by emergency lighting when building conditions require emergency lighting.

When an exit or the path to an exit is unclear, signs directing people to exits should be installed. Unlike the placement of exit signs, the placement of directional signs is less defined and those planning exit routes for people should use their best judgment when installing these.

That being said, too many signs may confuse people. Doors that are not exits and do not lead to exits but which are located near exits may be puzzling to people looking for a way out. According to Section 7.10.8.3 of the Life Safety Code, these doorways must be labeled "NO Exit," with "NO" in larger letters than "Exit" (two inches high for "NO" and one inch high for "Exit") to limit people mistaking the doorway for an exit. NFPA also suggests labeling non-exit doors; for example, a storage room could be labeled "Storage" to prevent confusion with an exit.

The Life Safety Code also requires exit signs in corridors to be installed so that viewing distance doesn't exceed the sign's rated viewing distance or 100 feet, whichever is less. This usually means signs will be placed 200 feet apart so someone between the signs is no more than 100 feet from an exit sign. NFPA reminds us this guideline applies only to corridors and not to large rooms, where the size of the sign (no smaller than six-inch lettering) determines the frequency of placement.

The placement of exit signs and adequate lighting in a building requires good judgment. When installing signs and lighting, keep in mind their placement should allow people new to the building to find their way outside quickly and easily. Doing so will ensure safe and speedy exits.

## Is All Your Property Covered?

Do you know if all of your municipality's property is insured?

Have you recently built a new building or bought a new vehicle?

Has your municipality been given a piece of property or land as a gift?

#### Does your insurance carrier know about it?

With the amount of hurricane damage Alabama sustained over the past two years, some municipalities found out the hard way that not everything they thought was insured was covered. It is critical for municipalities to check their coverage schedules and make sure everything they want insured is listed.

Every year, 90 days before the expiration date, AMIC sends out a pre-renewal coverage schedule with a renewal letter asking for any changes that need to be made. This schedule lists everything covered on the policy, including property, inland marine, liability, crime and auto insurance. This list is sent out every year, even to those of you with three-year policies. It is **your** responsibility to check and make certain the list is complete and up to date. If in doubt, call your agent and ask them any questions you have about your coverage.

Whenever a municipality receives any new property, be it a new structure you have built or a piece of land given to you by a generous citizen, please remember you need to contact your agent to make sure you get coverage for it. Don't get caught in the rain when the next storm comes. Make sure all your property is covered.

# Risk Management Awards for 2005

Instituting risk management and loss control activities by the members of the Municipal Workers Compensation Fund (MWCF) and the Alabama Municipal Insurance Corporation (AMIC) are considered to be proactive steps that benefit not only the member's loss ratio but the overall success of the MWCF and AMIC insurance programs. Not only are employee, property and liability losses minimized, but – most importantly – employees and citizens reap the rewards of a safer workplace and community.

In recognition of the efforts and successes of our members, the Board of Directors of the MWCF and AMIC approved the establishment of a Risk Management Award during 2002. It was determined that an award program would be developed based on the loss ratios for the member's prior year. For those members of both the MWCF and AMIC programs, the loss ratios would be combined and divided by two to reflect the overall loss ratio.

Four levels of awards are being presented to acknowledge the efforts and accomplishments of those members in the areas of Risk Management for the year 2005. Members are eligible to receive the Presidents Award once every five years and the Gold, Silver and Bronze annually.

- ALM President's Award; Top 5% for 5 years
- Gold Award; Loss Ratio below 5%
- Silver Award; Loss Ratio of 5% to 20%
- Bronze Award; Loss Ratio of 20% to 40%

Awards were mailed to the recipients along with a press release. Recipients of these awards are being acknowledged in this issue of the *Risk Management Solutions* newsletter and at the League Convention.
