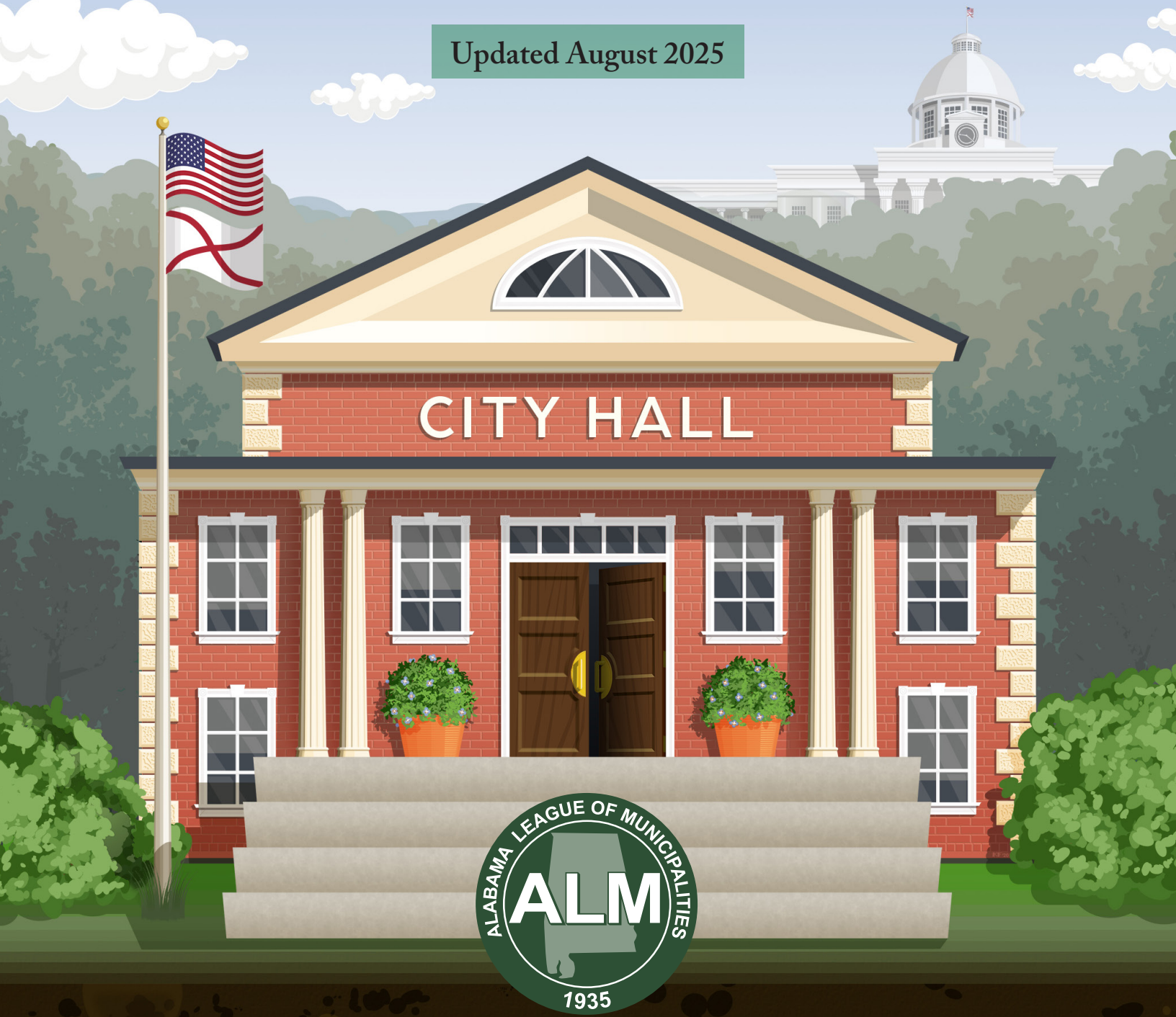

Additional Law Enforcement Reporting Requirements

Use of Force Reporting

All law enforcement agencies must report use of force actions by a law enforcement officer if the actions resulted in the death or serious bodily injury of a person, or a discharge of a firearm at or in the direction of a person. Use of force reports should be submitted by the fifth of the next month following the date of the incident.

Alabama Forfeiture Accountability System (AFAS)

The Alabama Forfeiture Information Reporting Act requires criminal justice agencies to report all property seized by a state, county, or municipal law enforcement agency for forfeiture in connection with a criminal event to the Alabama Law Enforcement Agency's (ALEA) Criminal Justice Information Services Division (CJIS) (§41-9-655.01 AL Code). ALEA CJIS collects this information through the Alabama Forfeiture Accountability System and provides an annual report to the legislature and governor summarizing the reported seizures by February 1st the following year.

Firearms Prohibited Person Database (FPPD)

During the 2021 session, the Alabama Legislature passed the Alabama Uniform Concealed Carry Act. This act mandates ALEA create, maintain, and administer a database of persons prohibited from possessing firearms, now known as the Firearms Prohibited Person Database (FPPD) (§41-27-3.3 AL Code). Agencies must record arrests through the state identification reporting system for ALEA CJIS to determine persons to be added to this database.

Domestic Violence Reporting

Municipal courts must report all dispositions involving municipal crimes of domestic violence to ALEA CJIS. Note that all law enforcement agencies are also required to note if an event involves domestic violence in the Uniform Crime Reporting (UCR) reports.

Allegations of Excessive Force

There is also an agency-related report that may be provided to ALEA CJIS when a victim of or a witness makes an allegation of excessive use of force by a law enforcement officer to a law enforcement agency. When a complaint is received, ALEA CJIS Form 16 should be presented to the complainant whose responsibility is to complete and return to the ALEA CJIS Incident Reporting Unit. Once received and reviewed by ALEA CJIS, the Incident Reporting Unit will reach out to the respective law enforcement agency for more details. ALEA CJIS prepares an annual report to the Alabama Legislature on such reported incidents.

*Most mandatory reports require agencies to provide a “zero report” when no incidents or actions are taken by the agency that qualify for reporting. Zero reporting allows ALEA CJIS to recognize that no event or action qualifies within that jurisdiction verses designating an agency for a failure to report.

Annual Municipal Court Fees and Fines Report

Agency Reported To: Alabama Administrative Office of Courts

Report Due Date: Annually, December 1st

Who is Required to Report: Municipalities with a municipal court

Summary of Reporting Requirements: The total court cases for the fiscal year; municipal revenue collected by the municipal court and the amount dispersed to each receiving entity; total expenditures by the municipal court, including annual salaries for the judge or judges, court clerk, and magistrate or magistrates; total annual operating budget for the municipal court; and total annual operating budget for the municipality.

Penalties: Any municipal court that fails to submit the required data within 60 days of the due date shall forfeit any fees and costs collected by the court that would otherwise remain with the municipal court or municipality until the data is submitted. Any forfeited fees and costs shall be transferred to the state comptroller for distribution to the Alabama Administrative Office of Courts. Further, the municipality may be subjected to an audit by the Alabama Department of Examiners of Public Accounts at the expense of the municipality.

Future Reporting Changes: By January 1, 2025, all municipal courts shall use one of the following:

1. The state judicial information system approved for the Unified Judicial System by the Administrative Office of Courts.
2. A court information system in which the court software provider is properly integrated with the state judicial information system for reporting purposes. The court information system shall conform to adequate technical parameters for reporting case management and financial information data to the Administrative Office of Courts. Data shall be accepted by the Administrative Office of Courts at no cost to a municipality.

Annual Transportation Plan

Agency Reported To: Posted at city hall and on the city's website, if available

Report Due Date(s):

- Annually, First meeting of January - Engineer Report
- Annually, August 31st - Council Annual Transportation Plan

Who is Required to Report: All municipalities

Summary of Reporting Requirements: Municipality must adopt, by majority vote of the council, an annual transportation plan that has a detailed list of projects for which expenditures are intended to be made in the next fiscal year based on an estimate of the revenues from the fund. Furthermore, at the first meeting in January of each year, the municipal engineer or other person designated by the council must present an annual written report detailing expenditures made with Rebuild Alabama Act funds during the previous fiscal year. The report must include the status of each project included in the previous fiscal year's Transportation Plan. The report must be entered into the minutes at a council meeting.

Code Section: Section 23-8-8(d) and 23-8-8(e), Code of Alabama 1975.

Local Motor Fuels Report

Agency Reported To: Alabama Department of Revenue

Report Due Date: Annually, January 31st

Who is Required to Report: All municipalities that have a local motor fuel excise rate established by local ordinance

Summary of Reporting Requirements: The total amount of local motor fuel excise tax revenues collected for the previous fiscal year. Also, the total amount of the revenues expended on road and bridge maintenance and improvement during that same fiscal year. The reporting information should not include other gas tax revenue received from the state.

Business License Tax Contractor Report

Report Due Date: Annually, August 1st

Who is Required to Report: Municipalities that contract with a private entity to collect business privilege taxes or business license taxes on behalf of the municipality

Summary of Reporting Requirements: Contact information of the private entity that collects business privilege taxes or business license taxes on behalf of the municipality.

Business License Tax Report

Agency Reported To: Alabama Department of Revenue

Report Due Date: Annually, March 30th

Who is Required to Report: All municipalities that levy a business privilege tax or business license tax

Summary of Reporting Requirements: The classifications and schedules for business license taxes. Also, whether the classifications or schedules changed during the reporting year or will change during the year immediately following the fiscal year covered by the report.

Municipalities that contract with a private entity to collect business privilege taxes or business license taxes on behalf of the municipality must notify the Alabama Department of Revenue of this fact on a form provided by the department.

Penalties: Any municipality or county that fails to comply shall escrow subsequent business license taxes and business privilege taxes until the municipality or county achieves compliance.

Report Due Date: Within 10 days of canvassing the results

Who is Required to Report: All municipalities

Summary of Reporting Requirements: Certificate of election for each candidate elected

Campaign Finance Reporting Changes: In the past, municipal candidates were required to file campaign finance forms with the probate judge within five days of qualifying with the city clerk, regardless of whether they raised or spent any money. Beginning June 1, 2024, municipal candidates are not required to file an Appointment of Principal Campaign Committee or any monthly, weekly or daily campaign disclosure reports after they qualify with their city clerk, unless and until they raise or spend in excess of \$1,000. If a municipal candidate raises or spends over \$1,000, he or she must file electronically with the Alabama Secretary of State at FCPA.AlabamaVotes.gov. For more information, please read **Act 2024-104**.

Full-Time Law Enforcement Employees Report

Agency Reported To: Alabama Law Enforcement Agency

Report Due Date: Annually, December 1st

Who is Required to Report: All municipalities with law enforcement agencies

Summary of Reporting Requirements: All law enforcement agencies should report the number of full-time employees, both civilian and sworn, by December 1st each year, based on the count from October 31st. Even if there are no employees, a zero report should be submitted.

Penalties: Failure to report will also lead to a zero designation, which will be submitted to the US Department of Justice and shared with the Alabama Legislature.

Local Highway Finance Report (Form 536)

Agency Reported To: Alabama Department of Transportation

Report Due Date: Biennially on March 31st of odd numbered years

Who is Required to Report: All municipalities

Summary of Reporting Requirements: Form FHWA-536 provides for the reporting of four basic areas of local highway finance: (1) disposition of highway-user revenues; (2) revenues used for roads and streets, identified by source and type of funds; (3) road and street expenditures identified by purpose or activity; and (4) local highway debt status. Form FHWA-536 should report the disposition of all highway-user revenues available to local governments for expenditure, and all receipts and expenditures related to: (1) the construction, maintenance, operation, and administration of roads, streets, alleys, and other public ways; (2) traffic police and road patrols; and (3) debt service and status of bonds and notes issued to finance highway activities. The information required is for the previous fiscal year.

Monthly Municipal Court Fees and Fines Report

Agency Reported To: Alabama Finance Department – Comptroller’s Office

Report Due Date: Monthly

Who is Required to Report: Municipalities with a municipal court

Summary of Reporting Requirements: Municipalities with a municipal court must transmit each month to the Comptroller’s Office the MC-13 Monthly Report To State Treasurer By Municipality form electronically for the fees and fines collected during the preceding month. Once you have completed your electronic MC-13 form, please mail the corresponding remittance check, along with the original physical MC-13 form, to the following address:

Penalties: Failure to submit the data required within 60 days of the due date shall result in the forfeiting of any fees and costs collected by the court that would otherwise remain with the municipality.

Municipal Audit

Agency Reported To: Alabama Department of Examiners of Public Accounts

Report Due Date: Audits (or audit reports where applicable) are due within 60 days of completion

Who is Required to Report: All municipalities

Summary of Reporting Requirements: Municipalities with annual expenditures of \$300,000 or more are required to have an annual audit conducted of the financial affairs and transactions of all funds and activities of the municipality by an independent public accountant for each fiscal year.

Except as provided in the link below, municipalities with annual expenditures of less than \$300,000 are required to provide for and cause to be made a biennial audit of the financial affairs and transactions of all funds and activities of the municipality by an independent public accountant for each fiscal year of the municipality. The audit is required to include each fiscal year since the previous audit.

In a municipality with annual expenditures of less than \$100,000, the city council may elect to provide for and direct the mayor or city manager to cause to be made, in lieu of the biennial audit an annual report that complies with procedures established by the Alabama Department of Examiners of Public Accounts. The annual report shall be provided to the Alabama Department of Examiners of Public Accounts and shall constitute an annual audit report.

Penalties: The department has the authority to assess financial penalties up to \$250 per week against municipal officials or municipal councils for failure or refusal to perform audits or submit audits requested by the department. These penalties are assessed against individuals personally.

Code Section: Sections 11-43-85 and 41-5A-12.1, Code of Alabama 1975.

Police Jurisdiction Report

Agency Reported To: Alabama Department of Examiners of Public Accounts

Report Due Date: Annually, March 1st

Who is Required to Report: Any municipality collecting license revenue or other taxes and fees within its police jurisdiction outside the corporate limits

Summary of Reporting Requirements: An accounting of all license revenues, and other taxes or fees, collected in the police jurisdiction outside the corporate limits during the previous fiscal year; a list of the services provided by the municipality and a list of service providers within the police jurisdiction outside the corporate limits. If the municipality provides police or fire protection within the police jurisdiction, the report shall include: the total annual budget for each police department and fire department within the municipal corporate limits; the total number of calls responded to by each police or fire department within the municipal corporate limits; and the total number of calls responded to by each police or fire department within the police jurisdiction.

Penalties: Municipalities who fail to file the annual report within 12 months of its due date permanently lose the authority to continue collecting licenses and taxes within the police jurisdiction.

Rebuild Alabama Act Contractor Report

Agency Reported To: President Pro Tempore of the Senate; Speaker of the House; and Chair of the Joint Transportation Committee

Report Due Date: Annually, October 1st

Who is Required to Report: All municipalities that have awarded projects using Rebuild Alabama Act funding

Summary of Reporting Requirements: Municipality shall provide a list of all contractors who have been awarded projects using Rebuild Alabama Act funds. Additionally, when using these funds, all county and municipal projects let to contract shall utilize contractors and material suppliers listed on the Alabama Department of Transportation's list of approved contractors and suppliers.

Rebuild Alabama Act Publishing Report

Agency Reported To: Alabama League of Municipalities

Report Due Date: The tenth day of the month preceding the bid opening and immediately after the completion of the project

Who is Required to Report: Any municipality using Rebuild Alabama Act funds

Summary of Reporting Requirements: A municipality must publish in electronic format the bid opening on a website maintained by the Alabama League of Municipalities. Additionally, on the same website, a municipalities may post the completion of each project to satisfy the specification and notice of bid openings.

Sales and Use Tax Exemption Report

Agency Reported To: Alabama Department of Revenue

Report Due Date: By July 1st

Who is Required to Report: Any municipality seeking to enact a sales and use tax exemption or repeal a sales and use tax exemption.

Summary of Reporting Requirements: A municipality must provide notice of the ordinance that exempts municipal sales and use tax either for a fixed duration in fiscal year increments or in perpetuity to the Alabama Department of Revenue by July 1st prior to the effective date of the exemption. Additionally, all effective dates for an exemption must be September 1st. For a municipality wanting to rescind an exemption, it must also provide the same notice by July 1st with an effective date of September 1st.

Sexual Assault Cases Reporting

Agency Reported To: Alabama Law Enforcement Agency

Report Due Date: Annually, by April 1st

Who is Required to Report: All law enforcement agencies

Summary of Reporting Requirements: Every law enforcement agency shall report all of the following information for the prior calendar year:

1. The number of new sexual assault cases reported;
2. The number of new sexual assault cases reported where evidence from a medical forensic examination was submitted for forensic analysis;
3. The number of sexual assault cases reported where evidence from a medical forensic examination was not submitted for forensic analysis and the reason it was not submitted;
4. The number of sexual assault cases that were closed due to judicial or investigative reasons and the reasons the cases were closed.

Even if there are no cases, a zero report is required.
